HOLIDAY RATES

Holiday rates apply only to the following: New Year's Day, July 4th, Labor Day, Thanksgiving Day and Christmas Day. On these legal holidays, the evening rate applies all day on dial-direct calls unless a lower rate would normally apply (nights and weekends). If these holidays fall on a weekend, but are celebrated on another day, the weekday rate (not 35% discount) will apply between 8 AM and 5 PM of the legally celebrated day.

LOWEST RATES—

Dial-direct one minute rates

Dial-direct calls are those calls within your LATA from a residence or business phone without operator assistance. The initial rate period is one minute any time of day or night. Charges are based upon rates in effect at the time of connection at the calling point. Charges for additional minutes change when the call continues into a new time period.

HIGHER RATES—

Calling Card (credit card) calls

Customer-dialed Calling Card calls always cost more than the dial-direct rate. An Operator Assistance Charge applies to all customer-dialed Calling Card calls. This charge, which is never discounted, is in addition to dial-direct rates.

Please note: Until an area has zero-plus calling and the ability to make customer-dialed Calling Card calls, this rate will apply to all Operator Assisted Calling Card calls.

HIGHEST RATES—

Operator-assisted

Operator Assistance Charges apply to person-to-person, third number billed, public (coin) telephone, collect, requests for time and charges, and calls from hotels. These charges, which are never discounted, are in addition to the dial-direct rates.
