MINUTES OF A MEETING OF THE PARK BOARD OF THE TOWN OF MENTONE

The Park Board of the Town of Mentone met at 7:30 P.M. February 28, 1957, with the following members present: Ned B. Igo, James E. Rodibaugh and C. O. Eiler. The meeting was called to order by Chairman Igo. The minutes of the meeting of January 17, 1957, were read and approved.

The Secretary reported that he mailed the park diagram to Prof N. W. Marty on January 18, 1957, but that no reply has been received as yet.

C. O. Eiler reported on the seeding of the pump house area and recommended that the area be seeded, fertilized with a disc drill, and then rolled with a catapiller tractor. A motion authorizing C. O. Eiler to order necessary seed and fertilizer carried. C. O. Eiler is to do the seeding; Ned B. Igo stated he would make arrangement for use of a disc drill. It is planned to use a catapiller tractor belonging to C. O. Mollenhour for the rolling operation.
