#### . Library Hours

Monday-Thursday: 9-7pm Friday: 9-5pm Saturday 9-1pm Sunday: CLOSED

#### . Item Loan Period

Books: 3 weeks Magazines: 3 weeks DVDs: 1 week Music CDs: 3 weeks Audio Books: 3 weeks Reference Materials: Need Director Permission

### . Resident Cards

We serve the town of Mentone and Harrison Township residents. Those paying property taxes are eligible for all library services.

### . Nonresident Membership

A nonresident family membership may be purchased. The yearly fee is set by the state of IN. This card is for families that are out of the service area.

### · Valley Card

Current students of TVSC, who are out of the service area are eligible for a Valley Card. This allows a nonresident student to Checkout up to 10 items. They are valid for 1 year and need to be updated yearly.

### . Application Process

Library Cards will be issued to patrons ages  $5 \neq up$ , with filled out an application form. A parent are guardian must sign for anyone under that age of 18, unless said person is an emancipated minor. Cards will be sent through the U.S. mail to verify address.

# . Drop Box

A drop box is available for patrons to return materials. It is located on the north side of the building across from the post office.

#### . Material Holds

Patrons may request materials to be reserved for them. When the item is available patron will be notified by telephone and material will be held for 3 days before the next person will be notified or item will be put on shelf.

# . Household Fines/Lost or Damaged Material

A household is a group of individuals living at the same physical address. An outstanding balance of \$10+ due to lost/damaged items may lead to restricted services. A patron will be allowed to checkout materials if a minimum payment of \$1 is made toward the fine.

Any lost or damaged item must be replaced at the retail price. An in-house fee of \$1 will be added.

# · Suspension

- 1. Willful destruction of property
- 2. Failure to return or replace borrowed material
- 3. Loud and/or abusive behavior within or on library property
- 4. Anyone using or allowing use of Card by nonresident to attempt to avoid charges
